# **Dear Neighbors (Alley Cleanup Update)**

Cochran Heights Neighborhood Association will be doing an audit of neighborhood alleys soon. We are conducting our audit as a result of a neighborhood survey that listed **Neighborhood Beautification and Safety** as top priorities. It is our hope that our audit will result in a more beautiful, safer neighborhood.

An earlier informal audit conducted on our neighborhood alley tour on Dec. 4 revealed many code violations, problems with city services, problems with utility services, as well as potential safety hazards affecting our neighborhood.

#### Code violations included:

- Excess trash Alley blockage Trees in power lines Poison ivy
- Leaking sprinkler systems

#### City and Utility Service violations included:

• Gas leaks • Dangling, downed wires • Pot holes • Poorly maintained

equipment • Temporary repairs not completed

## Potential problems for safety and homeowners included:

- Evidence of homeless people sleeping in alleys "Volunteer" trees beginning to grow under fence lines that could damage fences Leaking sprinkler systems contributing to mosquitoes and potential repairs
- Areas conductive to mosquito breeding Broken concrete resulting from tree roots Illegal dumping from contractors in the area

The neighborhood association conducted an alley cleanup day on April 9, to begin Clean up of the Milam/Pershing Alley, but more work is needed on all neighborhood alleys.

Maintenance of the area bordering the actual alley is a homeowner responsibility (if you are a renter, please notify your landlord and give them a copy of this letter). Prior to our formal neighborhood audit, we will hold a **Neighborhood Alley Clean-up Weekend** on **September 16-17, 2017**. It is the weekend before bulk trash making it easy for the city to collect any debris you put out that is acceptable for pick-up.

We will conduct our second neighborhood audit the week of September 23-30. At that time we will issue a CHNA Violation/Notice tag to address any issue considered to be in violation of city code, or to any homeowner we think may have a potential safety or other issue that could create an unforeseen expense if not remedied. After another month, we will do another audit and report any code violations to the City of Dallas that could result in a fine. We hope you will join us in our effort to make Cochran Heights a more beautiful and safe place to live.

These issues with the service are not a problem when our regular mail carrier is delivering the mail. He is always courteous and helpful and does his job well. We would like to suggest that better training could be provided for the substitutes that fill in on his route.

At the June meeting of the Cochran Heights Neighborhood Association, there was a discussion about recent problems with mail delivery service. As a result of that discussion, the board president, Sandy Sander distributed an email survey to collect data on residential experience with USPS service in our neighborhood. Results of the survey revealed that there have been significant problems with delivery service in the neighborhood during the past year. Most of the problems deal with delivery service provided by substitutes for our regular postman while he was ill. The majority of people are extremely satisfied with delivery provided by our regular postman. The board decided to take action by writing the postal service, pinpointing the problem, and suggesting a rigorous training program for those people filling in for regular workers.

# VIDEO CAMERAS CAN HELP FOIL CRIME

Doorbell video cameras are becoming cheaper to purchase and can help foil crimes such as package theft and break-ins. Many of the inexpensive cameras even allow an absent homeowner to speak through a doorbell speaker to someone ringing the doorbell as if the homeowner were actually home. In order for criminals to be prosecuted, positive identification of perpetrators is required. Video records of crimes can help immensely.

**CRIME** — Always report criminal incidents to 911. Residents can get information and police reports from the Dallas Police Department website: <a href="www.dallaspolice.net">www.dallaspolice.net</a>. Click on the section entitled "iWatch Dallas" to get information on downloading the app to your iPhone or Android.

**CODE VIOLATIONS** – Report code violations to 311.

**RESIDENT-ONLY PARKING** — Resident-only hanging parking permits are required to park on the 5100 and 5200 blocks of Pershing, Milam and Alcott on certain days at certain times. Check signs in your area for exact restrictions. Residential permits are available for purchase at:

Up to 6 permits can be purchased per household at \$6.50 each. Parking Permits cannot be ordered onine or by mail so bring your CURRENT drivers license, utility bill and proof of auto insurance with you. Planning a party? Temporary parking permits are available at The Oak Cliff Municipal Center for just 10 cents each.

Bulk Trash Pick Up is the week of the third Monday of each month. This month's pickup is September 18.

Trash is usually picked up by Wednesday, but can be earlier. You can set out your bulk trash as early as Thursday evening September 14.

Regular trash and recyclable materials (blue bin) are picked up once a week on Fridays. Order a blue bin by calling 311 or online:
