

BE A GOOD RECYCLER

- Look for the recycling symbol on your products. If it doesn't have a recycle symbol, don't put it in your bin.
- Wash out all your cans and bottles. The recycling companies don't want dirty containers.
- Include the screw on caps on all the bottles and cans. Rules have changed and those now go as a pair.
- Break down any carboard boxes you put in your bin. Remove any tape and labels.
- Some plastic bottles have wrap around labels. Those have to be removed or the bottle isn't considered recyclable.
- If your pizza box has grease on the bottom, only recycle the top. If they're both greasy, they go in the trash bin.
- Pieces of paper and plastic smaller than 3"x3" are considered trash.
- Painted and powder coated metals are not recyclable.

THE EXPERTS CORNER

Is Your Home Properly Insured???

Hi neighbors! After working with some of my clients in the aftermath of October's tornadoes, I have information that may be of benefit to you.

- When you first insured your home with your agent, it's likely a replacement cost calculator was used to determine the cost to replace your home. Unless you regularly counsel with your agent, that determined cost is probably old. You might have an endorsement called an 'Inflation Protector" that increases the dwelling coverage annually. This endorsement may, or may not, have kept up with the cost to replace your home. Additionally, if you made improvements or upgrades to your home since you first insured it, and you have not informed your insurance agent, you may not be properly insured.
- The cost to replace your home goes up exponentially during a catastrophe. It's
 a supply and demand thing. Building materials and labor cost increase when
 there's not enough supply.
- Depending on the age of your roof, and the company you are insured with, you
 may not receive replacement cost for your damaged roof. Some companies
 depreciate the roof over time.
- In some cases, debris removal costs take away from the dwelling coverage. Some policies offer a separate limit for debris removal in the event of a total loss. Example You have a \$200,000 home hit by a tornado and you have debris that must be removed, costing \$10,000. You will only have \$190,000 to rebuild your home.
- Wind/Hail deductibles have increased to 1% of your dwelling coverage and, in some cases more than 1%. Example – A home insured for \$200,000 Wind/Hail, a deductible of 1% would be \$2,000.

One last note, please consider what happens if you are underinsured and you have a partial loss. There's a "co-insurance clause" in your insurance contract that requires you insure your home for at least 80% of its replacement cost. As the cost of replacement increase with time and your coverage hasn't, you may find yourself underinsured. As an example, let's say your home has a replacement cost of \$100,000. You have a kitchen fire. After this fire, based on the replacement cost estimate, it shows that you are insured for under the \$80,000 that you are required to carry. In this situation, your claim payment for your kitchen fire will be reduced. Different contracts have different penalties for this situation. All this to say, it's important to know your coverage. It's even more important that you consult with your agent about the nuances of your own policy. THEY ARE NOT ALL ALIKE!!
